



Vidrio laminado espejo dorado superbrillante de 5 + 5 mm con lengüeta




¿Qué es el vidrio laminado espejo dorado con lengüeta?

El vidrio laminado con espejo dorado con lengüeta también se llama vidrio laminado con espejo dorado acanalado o vidrio laminado con espejo dorado acanalado. Este tipo de vidrio tiene la misma superficie que el vidrio estriado y el espejo dorado permite que este artículo brille, tiene un fuerte efecto decorativo y de privacidad.



El vidrio de espejo dorado con lengüeta utiliza vidrio con lengüeta y espejo dorado unidos con EVA de alta transmitancia o adhesivo de resina epoxi.




Capa intermedia de EVA
