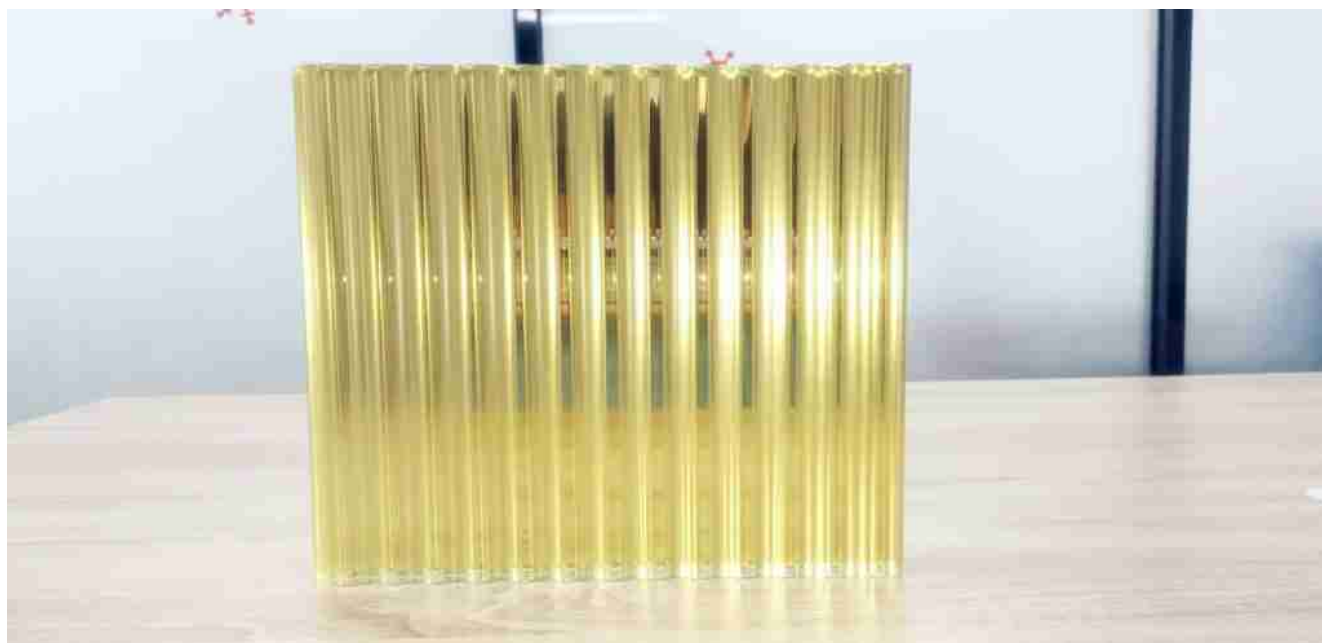
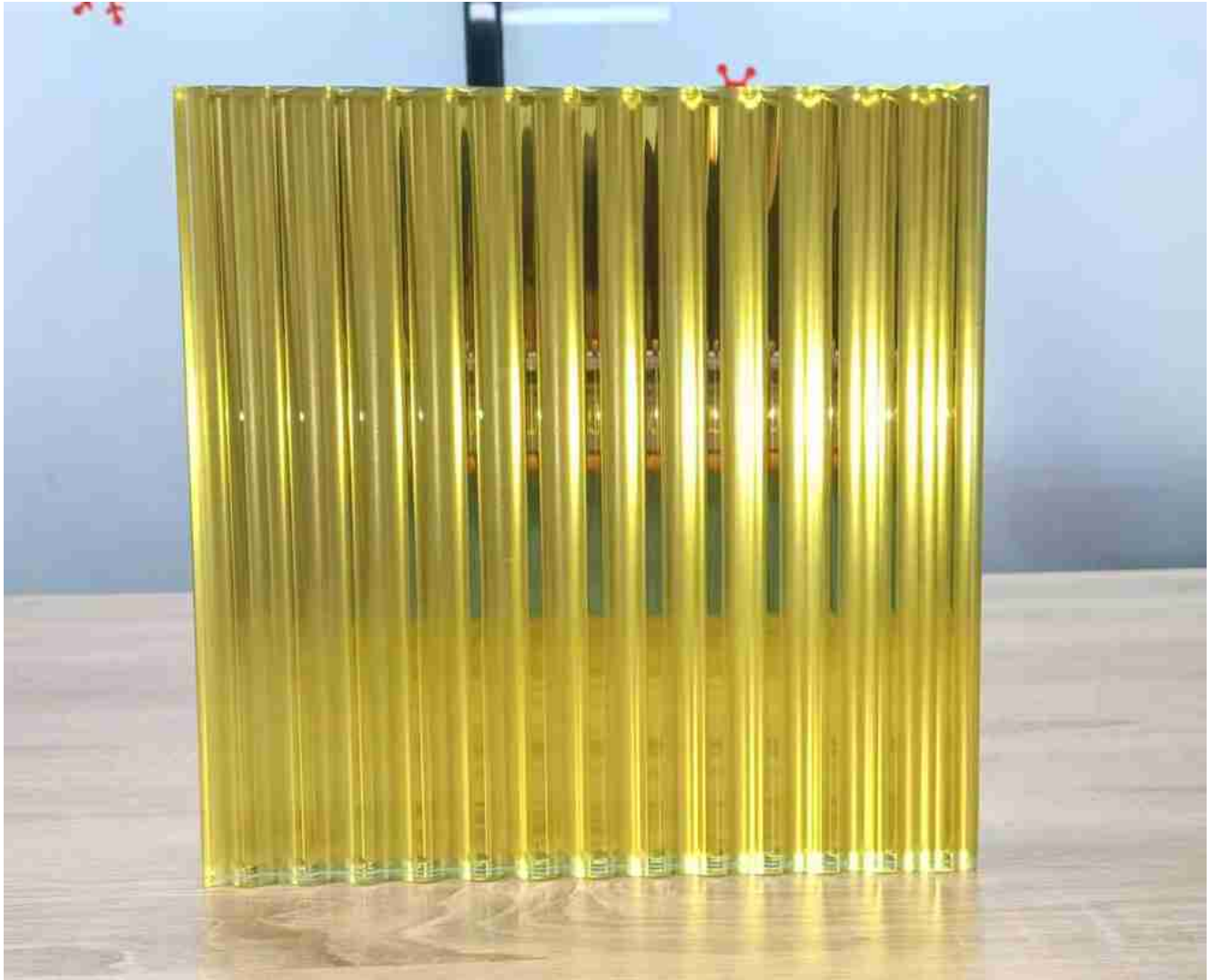


Super kimalteleva 5+5 mm rei'itetty kultainen peililaminoitu lasi



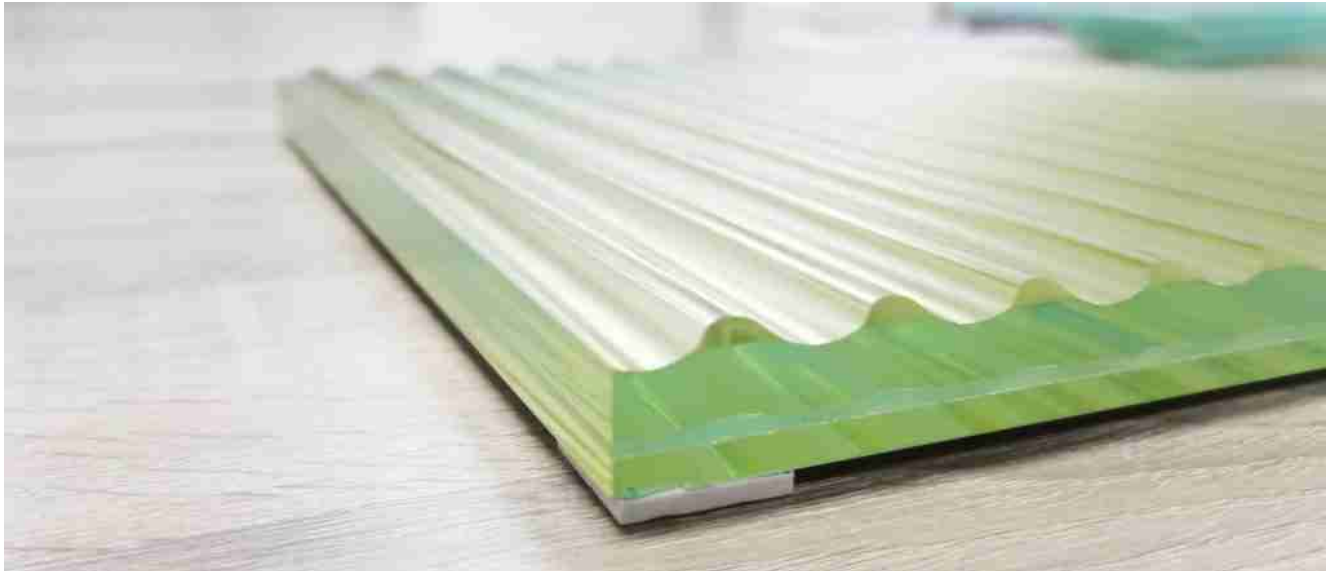
Mikä on harjattu kultapeililaminoitu lasi?

Reeded kultapeililaminoitua lasia kutsutaan myös uurteiseksi kultapeililaminoiduksi lasiksi tai uurteiseksi kultapeililaminoiduksi lasiksi. Tämän tyyppisessä lasissa on sama pinta kuin uurretulla lasilla ja kultapeili mahdollistaa tämän esineen loistamisen, sillä on vahva koristeellinen ja yksityisyysvaikutus.



Ruokokultaisessa peililasissa on käytetty harjalasia ja kultapeiliä, jotka on liimattu yhteen korkean läpäisevyyden omaavalla EVA- tai epoksihartsiliimalla.

metallilanka keskikerrokseen. Voit säätää kultaisen värin voimakkuutta. Kultaisella metallilangalla kultainen vaikutus on selvempi.
