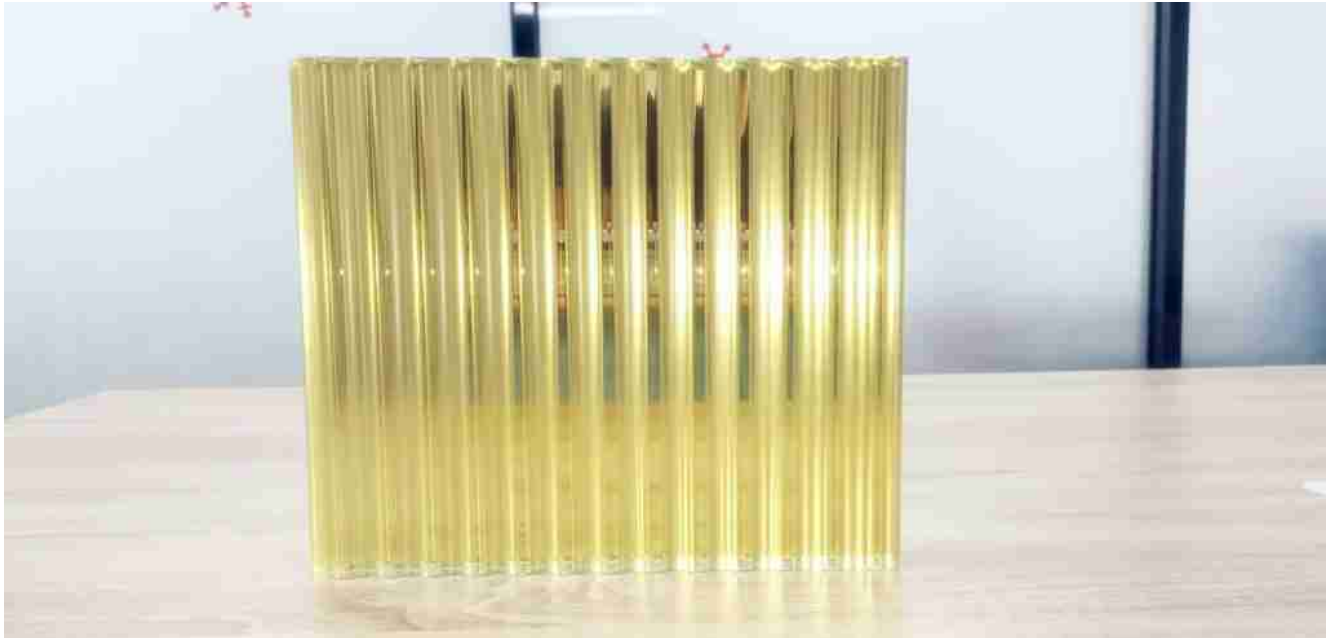
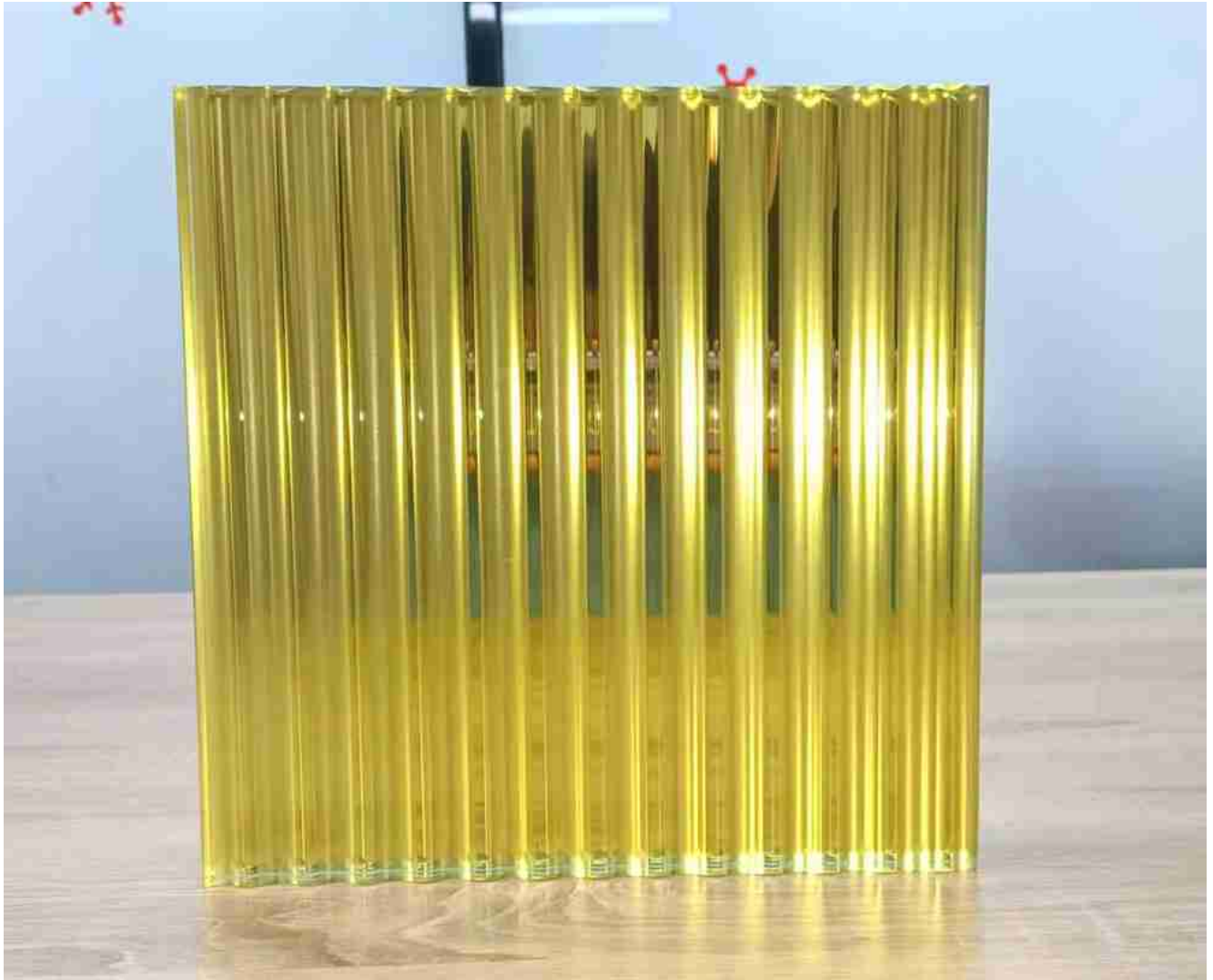

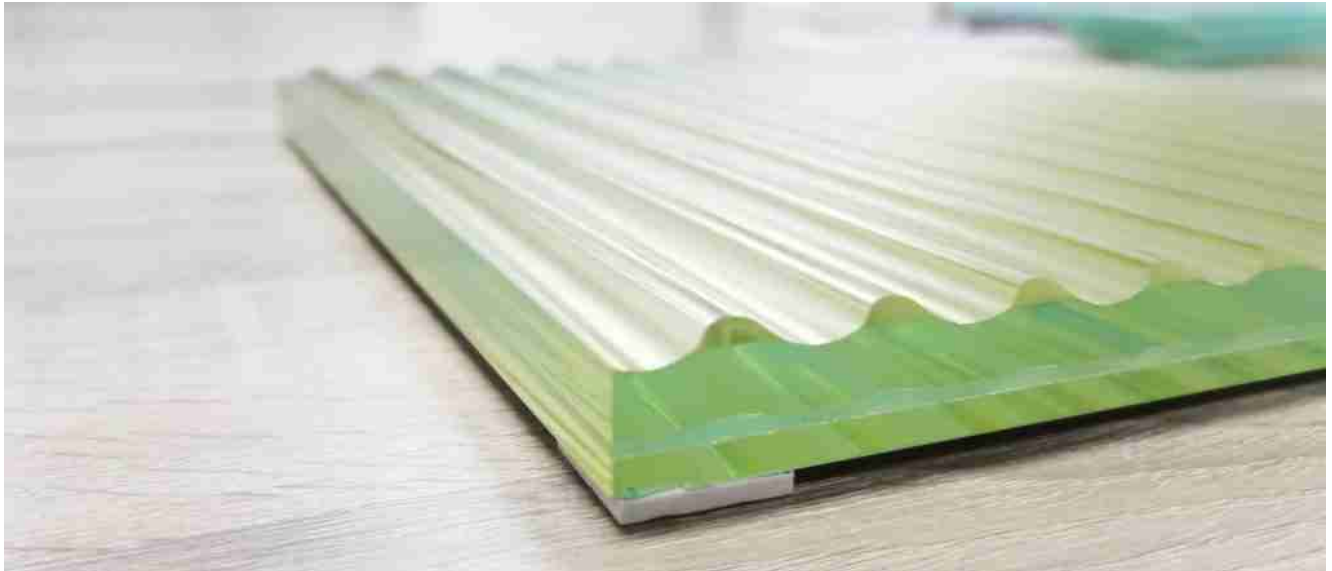
Hva er det laminerte speilglasset i gull?
